

Official Facebook Giveaway Rules & Regulations for Giveaway at the Facebook PhD Motivation & Wellbeing group by Motivated Academic

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who are members of the private PhD Motivation and Wellbeing group and meet the requirements of the giveaway.

2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of Motivated Academic as final and binding as it relates to the content of this Campaign.

3. Campaign Period: Entries will be accepted online starting on 11/11/2020 and ending 15/11/2020 11:59 PM GMT. All online entries must be received by 15/11/2020 11:59 PM GMT.

4. How to Enter: The Campaign must be entered by submitting a single entry via the online comments at the private PhD Motivation and Wellbeing group on Facebook <https://www.facebook.com/groups/phdwellbeing> .

The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Motivated Academic. Optional verbiage to include: You may enter only once.
